HISTORY.

CAUSATION - Predisposing *4. Previous attacks*
Exciting *Parturition*
Hereditary



DEURATION *10 days.*
Since her discharge from here she has continued quite well until today ago, & a fortnight ago she enquired and at the time is said to have had first parturition & soon afterwards she recovered all night until four days after, when she became restless, excited and very abusive swearing and using the most obscene and disgusting language. I left for a moment she attempted to get out of doors and in a nude state.

ON ADMISSION - Mind *In a restless excited state, noisy and abusive*
Body *She is anemic and debilitated. she has a syphilitic anemic taint and Phlegmasia Dolens of right leg.*

Since admission she has been restless, noisy in conversation in her conversation and abusive. She has Phlegmasia Dolens of right leg, so is therefore confined to bed. She throws all the clothes off her, and gets up in bed in a nude state shouting and singing - her habits are also very dirty and she only keeps a very short time during the night. Her breath is very foul, and she looks extremely ill, but she talks notwithstanding well. ^{12th} Was last night placed in padded room but she was restless and the door padding so had to be removed to enable her to arise after 2 1/2 hours. Phlegma she slept for several hours - She continues to take food well. ^{14th} Still excited and restless, and obliged to be kept in bed on account of Phlegmasia Dolens. She has been ordered Anonide Carb & Bark. - This is objectionable in her excitation and her language is very objectionable. She takes all her meals well. ^{16th} There is very little improvement in either her mental or physical state, for she continues excited & noisy. Phlegma has very little effect so Chloral has been substituted and with this special result. ^{17th} Still noisy, and restless, especially so at night when she shouts and sings. By still swollen but not so much so as it was. ^{18th} She is up to day, lying on the sofa. she still talks next incoherently and uses the most objectionable language. Phlegma has again been substituted for Chloral and after its administration she sleeps much better at night. She has to be dressed &c. her breath is better than it was and her leg is less swollen. ^{19th} Her health is very much better, she being now able to walk about. but her mental condition improves very slowly for she talks in the most rambling & incoherent way uses most disgusting language. she uses

dresses and washes herself but she does not
 employ herself in any way.

May 12th She improves slowly, for she now occupies herself
 sewing and assisting in cleaning the wards, she
 also sleeps without medicines, but she still talks
 incoherently and uses bad language.

June 11th She now talks more rationally and is not par-
 ticularly trouble, but she is at times rather restless
 at night and uneasy, she however has no pains
 and her health has very much improved.

July 16th She is now convalescent, for she answers questions
 sensibly and sleeps much better at night, lately
 she has been employed in the kitchen, and thus
 she makes herself very useful. She takes all her
 meals well and her health is now good.

August 4th Her mental condition is now in every way sa-
 tisfactory and should no unfavourable change
 take place she will be discharged at the next
 month as recovered.

August 29th 1882
 There being apparently no further reason for her
 further detention here she has been discharged
 Recovered.
