DURATION
14 days
Lately she has been attending religious meetings and has been influenced considerably by those who conduct them. This excitement is attributed as the cause of her treatment for 14 days ago she commenced to talk volubly about religion & has been gradually getting worse. She cannot sleep at night but talks short and sings. She is very restless all days quite unable to attend to her house or herself and is constantly talking in the most incoherent way, says she can see an Angel and she is continually washing herself with water. The impression that by so doing she will be made colder than snow &c. She talks all her words and her habits are clearly but she is rather inclined to be destructive.

ON ADMISSION
Mind In a very excited state, shouting and talking only in the most incoherent way.
Body Is well nourished, and she does not seem to be the subject of any organic disease.

Since admission she has been restless and talkative. Each night she did not sleep much although she kept in bed and was not disturbed. She sang and shouted and when excited only talked in the most incoherent way. To-day she is very loquacious and talks in the most rambling way, chiefly about Gray's and &c. She talks all her words as clearly as her habits and is managed without much difficulty for she is not mischievous and keeps her clothing on.
37th Restless and noisy at night singing &c and all day long she wanders about talking in an incoherent and rambling way. She is rather obstinate, untidy in her dress and does not employ herself in any way. Her habits have so far been clearly
38th She has been so noisy the last few nights that it has been necessary to prescribe sedative medicine for her. She still wanders about all day talking in a voluble and incoherent way.
39th There is no improvement whatever in her condition and for she restless and talkative by day and very noisy at night singing and talking and has in consequence to have high led. Is almost very restless. She talks her words well and is no trouble particularly, but she requires considerable working after for she is very untidy. Continues noisy restless and very flighty in her manner but since last report she has employed herself scrubbing the paragon. She talks incoherently and still requires high diet at Melrose. She is very untidy in her dress and will not lace up her boots &c. She takes all her meals well and enjoys very good health.
29th She is rather less excited than she was but still talks very incoherently and is frequently noisy at night but she does not now have any medicine at Melrose. She employs herself very irregularly and is very untidy.

 March 10th She is much quieter by day than she was here
 today in her dress and occupies herself to clean
 in the ward &c. Her conversation is however
 still very rambling at times and she is noisy
 at night singing hymns &c. She takes all her
 meals dressed and undresses herself and is steady
 in her habits.

April 23rd She now sleeps much better and does not sing
 at night. She also employs herself more regularly
 and is more rational in her manner and
 conversation. She has been employed for several
 days in the kitchen but had to return to
 the ward in consequence of a severe cold.

30th She has now quite recovered from her cold but
 has not returned to the kitchen, as she has
 expressed a wish not to go there. She employs
 herself in the ward and at needlework. She
 sleeps much better and is quiet at night.

May 10th She continues quiet and rational but does not
 seem very bright, however she converses sensibly
 and employs herself rationally regularly.

29th Her husband is very anxious indeed to give
 her a trial at home and as she now seems
 to be quite rational she ^{has been} discharged today
 upon a month's probation.
