CAUSATION

 Exciting Access of her son

She sleeps fairly well and has so far been quiet
 and manageable but she talks inordinately at
 vacantly staring about her is faulty in her habit
 and inclined to be destructive.

DURATION
 She has had two previous attacks and on both occasions
 has been an inmate of the Bristol Asylum Norwich.
 Six months ago she was discharged and although
 peculiar has been no trouble until a fortnight ago
 when she became more restless and ~~was~~ seemed
 very much upset by the fact that her son who is
 a widower had a strange woman in his house as a
 housekeeper. He is intemperate, talkative and at times
 her conversation is very incoherent. She does not
 display herself in any way but is constantly running
 about. She is disposed to be destructive to her clothing
 but she eats fairly well at night and takes all
 her meals.

She does not display herself in any way her habit
 is faulty and she is destructive to her clothing
 conversation is incoherent and when accused
 of destruction she denies it & blames some one else
 as she does when rebuked for her faulty habits
 she takes all her meals and is so particular, trouble
 sleeps well and takes all her meals but her
 habits are still faulty and she is destructive
 particularly so to her clothing

It has been ascertained that her son has been
 ill for some months and this is supposed to be
 the cause of present attack.

There is no alteration whatever in her mental ex-
 citation her habits are so faulty so ever she sits
 about all day talks inordinately and does not
 display herself in any way. Very untidy in
 her dress and artful in destroying things.

ON ADMISSION
 Mind Excited and voluble in her conversation which
 is very incoherent
 Body So well nourished. Lungs are healthy, heart's action
 is rather irregular and impulse more violent than
 normal but no bruit audible.

She continues as engaged in her ideas & is idle
 and faulty in her habits as ever
 She has lately somewhat improved in her habit
 are not so faulty and she is not disposed
 to be so destructive. She talks however, still in-
 coherently and spends her time in idleness
 She has been transferred to the auxiliary Asylum
 she is clearly in her habit and has not
 lately destroyed anything. She is very vacantly

does not employ herself in any way and still talks incoherently but is able to answer questions correctly.

October 20th

She has much improved for she makes herself useful in the ward, talks rationally and has abandoned her destructive habits. Her health too has much improved.

Nov. 6th

She is now employed as in looking after and keeping clean the female mess room which she does well. She seems now in every way rational, and will if she continues so be discharged next month.

December 24th
